## To Jewry in Poland

We stand in the heat of an unprecedented, unequal fight.

There is no security of life, health or property for the Jewish population, and the right to self-defence does not exist for us

The economic boycott leads, in the most brutal way, to the declassification and extermination of the Jewish population.

Bullets of terrible hatred are falling on us from all sides. There is no lie so monstrous, so vile that has not been cast upon the Jews of Poland.

As the Jewish parliamentary representation, during the last extraordinary session of the legislative bodies, and in votes, we clearly expressed the thoughts and feelings that the current reality imposes upon every Jew in Poland.

Today, we turn to you, the Jewish people in Poland.

The Przytyk affair [pogrom on 9<sup>th</sup> March 1936] is a new, severe test for Jewry in Poland. The pain gnaws at me, tugging at me as a heated protest bursts forth.

In this situation, there is but one command for us all – to build a defence rampart to protect against destruction and annihilation. The whole community, united and consolidated, must exert the greatest effort of will, courage and sacrifice.

There are no paths of individual salvation, no separate actions, stuck in ossified methods and patterns in the face of the wave of hatred that is directed at everyone. Who will be missing? Who will stand halfway? Who will, in any way, betray the duties resulting

from a sense of national dignity and the need for collective defence? They will stand alone or will be pilloried by Jewish public opinion.

And anyone who now shows signs of fear, who spreads defects or doubt, will sin gravely against the Jewish community.

Only our faith in the irreplaceable forces of our eternal nation and an unwavering faith in the victory of justice can sustain and lift us.

Wrapped in this faith, we stand in the most difficult conditions in the service of our defence to which we call upon all lewry.

Despite the fact that Roosevelt's gigantic plan has long been shaken to its foundation, and that the Supreme Court, which is controlled by the Republicans, is dealing him blow after blow, not even the bankruptcy of the "brains trust" and the outright rebellion in Roosevelt's own camp have not been able to shake the trust that he has spreading throughout the American population.

## Disgrace for the Nazi regime

There will not be a Thaelmann trial

Foreign press has reported that the Nazi government has withdrawn the indictment against well-known leader of the German communists, Ernst Thaelmann. There will, therefore, be no trial for "high treason", which was awaited by the public with great concern.

This does not mean that, after three years in prison, Thaelmann will be free and will no longer be in danger. On the contrary, in Nazi lawlessness, there is no question of human safety. The German government's disgrace, in this case, lies in the fact that they tried, at all costs, to construct an indictment and justify the death penalty.

Thanks to the leftist organisations still operating in the Third Reich, it was possible to obtain a photocopy of the indictment against the leader of the German communists, Ernst Thaelmann, who had been imprisoned, in Berlin, for over three years, and to be able to send this document abroad. German émigré magazines, as well as French and English, are currently publishing the text of this accusation.

Despite all efforts, no serious allegations have been made to convict this "enemy of the German nation".

Only now, we understand that, although the indictment was served on Thaelmann on 17<sup>th</sup> December

1934, the German court has not yet decided to hold the trial. It has scheduled it six times and has then postponed it six times.

Thaelmann, the son of a Hamburg dockworker, also worked at the port as a warehouseman, constantly educating himself, especially in sociology and economics.

At the age of seventeen, he joined the Socialist Party and soon became one of the workers' syndicates leaders. He violently opposed the imperialist plans of the German Empire.

Despite that, when called to arms, he did not use his pacifism as an ideological excuse from military service. He went to the front and was wounded twice. He was awarded the Iron Cross and the Hanseatic Cross.

After demobilisation, he became a member of the Hamburg Senate and, in 1924, a member of the Reichstag and chairman of the German Communist Party. In 1932, he ran for President of the Weimar Republic. He received five million votes and, after his arrest on 5th March 1933, he was re-elected as an MP in six constituencies.

Thaelmann was arrested a few days after the Reichstag fire on a charge that, despite being absent when the fire broke out, he was involved in it. However, this fantastic accusation was soon abandoned and, despite all efforts, no serious evidence of any guilt was found.

In prison, he suffered physical and moral torture. Being completely isolated, he could only shout, from a distance, to a visiting delegation from the Saar prison, "They are torturing me!!".

Finally, he was deprived of a defence lawyer. Although being an extreme right-winger, Roetter, his lawyer, protested against the prolonged and unjustified imprisonment of his client.

In March 1935, Roetter was arrested, together with his wife and then in July, he was released. However, he his right to practice law was removed and, from then on, Thaelmann did not even have a public defender.

He also had no witnesses — they were all exiled or removed from the Reich. His personal secretary, Scher, who refused to sign, under torture, a confession statement, was taken to the Potsdam Forest, together with two companions, where all three were murdered.

It is likely that Thaelmann will be transferred from the remand prison to a concentration camp, where he will probably stay indefinitely – "in accordance with the laws".

#### **New secret Nazi organisation**

The organisation was headed by "Gruppenführers", Günther Sornik and Jan Sornik.

Further investigations are ongoing.
